- Licensure Disclosure - Tokle
 - Federal regulations require that programs that lead to, or could lead to licensure, must disclose whether they meet the educational requirements to obtain licensure in every state and U.S. territory. All programs, not just online programs, must comply by July 1.
 - Units around campus are collecting information about licensing requirements and will submit their findings to Academic Affairs by May 15.
 - Academic Affairs is building a website for the public disclosures with easy access for students. A recommended letter for individual disclosures and timelines for contacting students will be provided to units as well.
