5. Report from the Executive Committee: did not meet, no report.

6. Information from Academic Affairs: Proposal status updates:

[Proposal #53](#) Chemistry (CHEM 1101)

Hofle met with Selena Grace and Joanne Tokle before winter break regarding removing courses from the Gen Ed Program. There is no precedent or procedure in the state for removal, so ISU can devise its own procedure. CHEM 1101 cannot be removed from the Gen Ed Program for at least another year, since every other institution in Idaho teaches CHEM 1101 as one of their Objective 5 GEM courses. For now, the Chemistry department will need to figure out a way of assessing CHEM 1101 as an Objective 5 course. Hofle said she reviewed the history with Grace and reiterated that CHEM 1101 should not have transitioned from the previous Gen Ed Goals into the new Gen Ed Objectives. Grace was amenable to GERC and UCC continuing to work this year on finding a satisfactory solution to this dilemma. Grace will also discuss this issue with the State Board of Education (SBOE) to get their input on how much leeway the universities have in deciding which courses to offer in Objectives 1 through 6 in the GEM system. GERC has complete purview over Objectives 7, 8 and 9 since those are ISU's discretionary Objectives.

[Proposal #57](#) Paramedic Science Academic Certificate

This proposal is on hold pending replies to Deans' Council's questions and concerns. It also requires a letter to the SBOE for their approval of this Certificate.

[Proposal #48](#) Entrepreneurial Leadership and Entrepreneurial Innovation minors, new MGT 2210

Academic Affairs denied the two new Entrepreneurial minors, but the rest of the proposal was approved.

7. Current Subcommittee Activities:

a. General Education Requirements Committee (GERC)

GERC met on Tuesday. The GERC chair had met with the Institutional Effectiveness and Assessment Committee that afternoon and reported on GERC's efforts and progress in reviewing and approving general education assessment plans. Most assessment plans have been approved, but there are still some plans that need revisions, and a few still to be submitted for

GERC's review. The open question is what can and may GERC do regarding general education courses for which a plan has not been submitted or approved.

Departments submitted their first round of assessment reports last fall. GERC plans to make a few modifications to the reporting form in response to feedback it has received. GERC also intends to start working on the backlogged items it had compiled of future business items. They will approve their final Gen Ed Course List for the 2017-18 catalog next week. Discussion. Departments have some latitude on how often they assess each learning outcome within the Objective. Tokle will check on the SBOE's expectations of frequency of assessing outcomes. Some adjustments to assessment schedules may be needed to maximize efficiency.

9. Information from the Faculty Senate and other Councils:

Faculty Senate met on Monday and continued their work on policies. Discussed Faculty Constitution, encouraged each Senator to talk with their constituents to find out what faculty want the constitution to include, and how much a priority it should be. A small group of 4 Senators will be reviewing previous versions of the Constitution as a starting point.

White demonstrated how to find and approve the online catalog pages. Each UCC council member will need to carefully review and approve the pages for their units' proposals before the pages can go to the next person in the approval chain. An automatic email will be sent out with the link for each page to be approved. UCC members need to finish their approvals by next Friday.

Read explained that she and White will transfer existing proposals in process from last fall into the new 2018-19 catalog proposal Tracking Sheet, so POs can continue working on their proposals without having to submit new requests.

Read showed and explained the changes she and White made to the proposal form. Discussion about how the new major Degree MAPs should be handled if submitted with the proposals. The Central Advising office needs MAPs to be submitted as Word documents rather than in another format. Ultimately all Degree MAPs will be posted on the Central Academic Advising website for departments to download and update with all proposed changes corresponding to UCC catalog proposals. The first page of the MAP listing the degree requirements will be published in the Undergraduate Catalog, hence the need for UCC to review and approve changes to the MAPs. Hertz and Zink will clarify the instructions in the proposal form for UCC to review next meeting. Meanwhile, Read will disable the proposal request links on the UCC website with a note saying the new forms will be available in February.

Members reviewed the proposed revisions to the form and made further suggestions, including tweaking the Impact Questionnaires to be consistent. Hofle mentioned the notation for removing a course from the gen ed program. She suggested GERC might consider systematically reviewing the SBOE's online Gen Ed portal to compare gen ed courses from each institution to get a better idea where it has flexibility and where it does not.

Much discussion. The UCC proposal process is being used as a mechanism for reminding departments to create and submit Degree MAPs to Central Academic Advising, or to update their existing Degree MAPs as needed. Hertz and Zink will indicate in the Advising impact statement whether Degree MAPs are required. Hunt and the Registrar's Office will check to make sure the Degree MAP and proposed catalog changes agree with each other. There is some question whether the catalog system will automatically update Degree MAPs with updated course titles, descriptions, etc., or if such changes will have to be done manually. The Academic Advising website is being updated, should be ready by February 6 or so. White verified that the Registrar's Office corrects Plans of Study in the catalog to match curriculum approved by UCC. Proposal form **tabled** until the MAP template revisions and new website links are finalized. Zink will touch base with Hertz to make sure she concurs with the revisions to the form.

Hofle spoke with Amanda Eakins in the Graduate School regarding the proposal form they use for the Graduate Catalog and suggested they consider adopting UCC's proposal form to make it easier and more consistent for proposal originators and the eCatalog editors. Eakins said she would be amenable to looking over UCC's form and taking it to Graduate Council for their consideration if warranted.

Jardine mentioned the Library was hosting a reception for Art department faculty and students this evening from 4:30 – 6:30 p.m.

6. Information from Academic Affairs:

Academic Affairs is updating ISU's 5-Year Plan of proposed program changes for the next few years. Departments should send all such proposals to Kelly Plummer-Sherrard in Academic Affairs, and she will record and route the proposals from there. Mid-cycle report to North West Council for Colleges and Universities accreditors (NWCCU) is due September 8. Academic Affairs will reconvene University Assessment Coordinators group this March. Tokle contacted the SBOE and verified they do not have a process for removing courses from Gen Ed program, so it will be up to UCC and GERC to create ISU's process. On behalf of Academic Affairs as well as herself, Tokle thanked everyone on UCC and GERC for their dedicated service and thoughtful discussions in these councils.

a. General Education Requirements Committee (GERC) –

Wilson reported GERC approved their final list of next year's Gen Ed courses, which this council will consider today. He informed members that in GERC's assessment process Objective Review Committees (ORCs) will be designated by departments to convene and review each Objective at the end of the reporting cycle. There is still a question what NWCCU expects in terms of frequency in assessing each course, outcome, and Objective. Tokle will have more information after the upcoming assessment workshop in March. She will answer some of GERC's other questions when they meet next week.

Hunt distributed a handout explaining the three goals the Registrar's Office and Advising are trying to accomplish with the Degree MAPs:

- Existing MAPs are in the hands of the Advising office and published in the online 2017-18 catalog, but not in the .PDF version yet.
 - UCC will not be asked to review and approve 2017-18 MAPs.
 - UCC will be asked to work with departments to solve problems found in the MAPs in time for publication in the 2018-19 catalog.
- All catalog changes processed by UCC for 2018-19 include either updated MAPs or newly created MAPs for programs that didn't have one.
 - MAPs will not be submitted with UCC proposals; instead MAPs need to be submitted to the appropriate Advising office.
 - UCC Proposals should not be held up if MAPs are not ready.
 - UCC will not need to review and approve MAPs yet, until all MAPs are created and published.
 - The Registrar's Office will make minor corrections to MAPs to ensure they match the catalog curriculum and course listings.
 - Once all MAPs are created and published, UCC will be involved in reviewing and approving changes and updates.
- Standardize program listings in the 2018-19 catalog.
 - Increase coherence between program requirements, university requirements, MAP and DegreeAudit. Would benefit students and help them be more successful.
 - UCC to approve standard program elements and methodology for counting credits required for degree completion. Registrar and Advising would then update the MAPs for as many programs as possible.
 - Suggested program elements – *still need definitions created*
 - Program Admission
 - General Education
 - Program Core
 - Major Requirements
 - Concentration Requirements

Program Electives
Upper Division Electives
Free Electives

Hofle would like to receive an initial draft of how a MAP would look in the catalog as well as the definitions. *Hunt will provide them for UCC's consideration in their next meeting.* UCC reps will need to work with their Proposal Originators to ensure they are aware MAPs will be required, and know where to go to get more information.

General Education *(for the 2017-18 Catalog)*

The General Education Program

The General Education program at Idaho State University prepares students to be life-long, independent learners and active, culturally aware participants in diverse local, national, and global communities. As the foundation for all further studies, General Education promotes comprehensive literacy - including effective communication, mathematical, and technological skills; reasoning and creativity; and information literacy - and a broad knowledge base in the liberal arts.

General Skills and Abilities

Through completing the General Education program, students will be able to:

- Communicate effectively and clearly in standard written and spoken language;
- Use mathematical language and quantitative reasoning effectively;
- Think logically, critically, and creatively; and
- Locate relevant sources and use them critically and responsibly.

General Education Requirements: The Nine Objectives

All students must complete a minimum of 36 credits from the nine Core Objective areas as outlined below. All students must meet Objectives 1 through 6, Objective 9 and choose to meet either Objective 7 or 8.

If a student does not meet the minimum credits required (36) once all 9 Core Objective areas have been met, the student must complete additional coursework from any of the outlined Core Objective areas to meet the 36 credit minimum.

Objective 1, Written Communication:

Minimum of two (2) courses. (6 credits)

Upon completion of the courses in this category, students are able to demonstrate the following competencies:

- Use flexible writing process strategies to generate, develop, revise, edit, and proofread texts.
- Adopt strategies and genre appropriate to the rhetorical situation.

The General Education program at Idaho State University prepares students to be life-long, independent learners and active, culturally aware participants in diverse local, national, and global communities. As the foundation for all further studies, General Education promotes comprehensive literacy - including effective communication, mathematical, and technological skills; reasoning and creativity; and information literacy - and a broad knowledge base in the liberal arts.

General Skills and Abilities

Through completing the General Education program, students will be able to:

- Communicate effectively and clearly in standard written and spoken language;
- Use mathematical language and quantitative reasoning effectively;
- Think logically, critically, and creatively; and

This is not to say GERC has made any determination whether ISU should be part of the Passport Program. GERC elected its officers for next year: Sandi Shropshire will continue as Chair, Jim Skidmore will be Vice Chair, and Cara Esplin will be Secretary. For ISU's mid-cycle accreditation report due in October, the report will use Pharmacy and GERC as example assessment procedures. GERC is also discussing where the assessment data gathered ought to be published and who ought to access to that data. GERC has also been frustrated by the lack of response from two departments despite GERC's ongoing and repeated efforts to get assessment plans. One other department has submitted most of its plans but has a few still outstanding. GERC has exhausted its means, now the chair will formally notify UCC and Academic Affairs as the next level up the hierarchical chain. This coming Tuesday a small subcommittee of GERC will meet to clean up the approved assessment plans in preparation for publishing on GERC's website.

Zink said Sherri Dienstfrey-Swanson visited the BAS Committee to discuss the idea of creating an Honors BAS degree. Unclear whether BAS Committee has the authority to do this on their own, or if UCC should weigh in. Houghton said the problem lies in the fact that proposals require a faculty vote: who are the faculty that should vote on an Honors BAS degree proposal? Question for UCC is: whether sufficient for BAS committee to vote on the UCC proposal, or is there another level of faculty vote that will be needed.

UCC's consensus was to have the Honors Program work with Chris Hunt to create a list of the faculty who taught an Honors course or Honors contract course last year, and to consider those faculty as the Honors Program faculty. BAS Committee reps should formally solicit written feedback from their colleges before the BAS committee votes whether to move forward with a UCC proposal to create

HBAS degree. Honors faculty would then review and vote on the proposal as the program faculty.
Would require a letter of notification to SBOE for this new degree.

4. Report from the Executive Committee:

a. **New method for correcting minor catalog errors:**

The Executive Committee met just before today’s UCC meeting and discussed a way of fixing minor errors in the catalog without the need for a full UCC proposal. Departments can contact Hunt in the Registrar’s Office to let him know what corrections are desired. Hunt would create a memo detailing the exact changes to be made in the catalog. That memo would be presented to UCC’s Executive Committee for its consideration. If the Executive Committee concurs the change is a minor correction and does not warrant a full proposal, the memo would then be brought to the full UCC for its consideration and approval as a Consent Calendar item. As with any Consent Calendar item, any member could pull it for further discussion and deliberation. If UCC approves the change, the memo would be attached to UCC’s Minutes and forwarded to Deans’ Council and Academic Affairs for their review and approval in the usual manner.

b. **Honors B.A.S. degree faculty vote update**

UCC had decided last spring that the faculty who have recently taught Honors courses should constitute the faculty to vote on catalog proposals from the Honors Program. Executive Committee suggested Hunt can provide a list of faculty who have taught Honors sections to the Honors Program director, who can then add the faculty who have taught Honors contract courses. The question for UCC to resolve is how far back to go to create the list.

UCC **voted affirmatively** to designate faculty who have taught Honors sections or contract courses in the **most recent academic year** to count as the eligible voting faculty for Honors Program proposals.

After UCC, State program proposals must be approved by Deans' Council, Finance & Administration, Provost, President, then go to SBOE for 30-day review by all other Idaho secondary ed institutions, after which it goes to Council on Academic Affairs and Programs (CAAP), then to IRSA (Instruction, Research and Student Affairs) subcommittee, and BAHHR (Business Affairs & Human Resources) if professional fees are involved, and then ultimately to the SBOE for its final approval. Some program changes also require approval by ISU's accreditors NWCCU (North West Council of Colleges and Universities).

Bottom line: submit UCC catalog change proposals in January, February or March that have corresponding full State Proposals. Be aware the catalog editors will be busy preparing the new fall catalog for publication in time for Early Registration in April, so submit new proposal requests as soon as possible after UCC's catalog cycle ends in mid-November, and be patient in waiting for the requests to be processed.

Background: Program catalog listings are varied in their structure and how credits are counted. A standardized format and method for counting credits is needed. The subcommittee worked on this over the summer and will present its recommendations to the entire UCC in August for consideration for the 2018-19 catalog.

Hunt distributed three handouts: one explanatory document on Standardizing Program Listings ([Appendix C](#)) and two sample standardized program listings. ([Appendix D](#)).

He described the process the committee developed. The Gen Ed program courses are listed separately from the program core and major requirements for clarity's sake. This standardization process will identify questions in programs' requirements so they can be clarified and resolved. This should help students understand at a glance what each program requires. UCC and departments would be fully involved in the development of these program listings. Discussion ensued.

Council voted to **approve** the standardization of program listings into the format shown in the two samples. ([Appendix B](#))

Hunt asked members to let their Proposal Originators know he is working his way through the impact requests he has received and to be patient.

2. Update on Pre-Pharmacy impact regarding AY2017-18 [Proposal #36](#) – Jim Lai
Pre-Pharmacy students will now have to take four additional credits in Biology. Lai said Pharmacy has another proposal in the works to solve the problem. He will look up in last year's proposal to find the rationale behind the Biology change. Members were reminded to watch all proposals closely for non-obvious impacts on their constituents' programs.

Last Fall (2016) UCC decided all pre-reqs are to be listed in catalog curriculum. [AY2018 UCC Proposal #57](#) Paramedic Science Academic Certificate was amended to add the required pre-reqs BIOL 1101 & BIOL 1101L. **The Program still needs to submit Degree MAPs to Central Academic Advising. Tabled again** to have the department integrate this proposal into their other one in the works.
3. [Proposal #5](#) from the **Bachelor of Applied Science Program** to create a new BAS major in Robotics & Communications Systems Engineering Technology. **Tabled** (with 1 opposed) for further deliberation to define criteria and policy for 'upper division' classification. **The Program still needs to submit Degree MAPs to Central Academic Advising. Requires approval by SBOE and NWCCU.** (Corresponds to **State Proposal #2017-03**).

C. Subcommittee's Handout on Standardizing Program Listings:

Standardizing Program Listings

Purpose:

To assist students to meet their goals, the Undergraduate Curriculum Council (UCC) believes that all programs should be clearly defined and listed in the undergraduate catalog, including program admissions requirements, major requirements, non-course requirements, as well as university requirements such as total number of credits, free electives, and upper division credits.

Standardizing methods of listing program requirements will benefit ISU students in the following ways:

- It will facilitate ensuring that the catalog, MAPs, and the degree audit are all providing students with the same information.
- It will ensure that all published programs include university requirements such as total number of credits, free electives, and upper division credits.
- It will allow a program to show where general education courses also fulfill program requirements, and it ensures that credit totals are accurate.

To aid in this process, the UCC will be reviewing all programs and ensuring any requirements listed in narrative are also all included in the list of requirements.

Rules:

- All programs will list each of its elements in a grid format. Examples of these elements are: program admissions requirements, non-course requirements, GPA requirements, and any other special graduation requirements.
- Each grid will be comprised of at least four (4) category blocks. These blocks are: general education block, admissions requirements block, program requirements block, and program totals block. Any non-applicable blocks will be identified as non-applicable.
- General Education Block
 - o The general education block will show the minimum number of credits necessary to fulfill the program's general education objectives.
 - o Specific general education courses that are required for the major will be identified in this block. Confirmation will be requested from the department to.

differentiate any suggested general education courses versus required general education courses.

- Program Admission Block
 - All programs will include a program admission block. If there are no program admission requirements, it will be identified as non-applicable. Confirmation will be requested from the department to differentiate required vs suggested admission elements.
- Major Requirements Block
 - If program common core requirements exist, they will appear in a separate block.
 - Any major requirement course that is also a general education requirement will indicate specifically which general education requirement it fulfills.
 - All program options will be shown. (e.g. concentrations, emphases, tracks.)
 - Major Electives requirements will either include a list of specific courses from which the student may choose or include guidelines for students regarding choosing acceptable electives to meet major requirements. Clarification regarding student choice of major electives will be requested from the department and ultimately will be reflected in the major requirement block.
 - Alphabetical listing of courses by subject in each block is preferred.
 - Prerequisites for all required courses will be included, except for prerequisites to general education English and Math courses.
- Program Total Block
 - The program total block will show credit totals from the sub-blocks of General Education, Program Admission, and Major Requirements, as well as Upper Division Electives, and Free Electives to meet university requirements. Program Admissions Requirements, Upper Division Free Electives, and Free Electives will be listed even if they are not required. Any non-applicable category will be identified as non-applicable.
 - Free Electives are credits not specified in the program blocks and needed to fulfill University total credit requirements (e.g. The University requires 120 credits for a baccalaureate degree and Free Electives may be needed to attain the total).
 - Upper Division Free Electives are upper division credits not specified in the program blocks and needed to fulfill University upper division credit requirements. (i.e. The University requires 36 upper division credits for a baccalaureate degree.)
 - If any sub-block includes courses that also fulfill a general education requirement, the credits for these courses will not be included in the total credits listed for that sub-block, as the course will fulfill both requirements, but only count once towards degree totals.

Process:

- As program changes are made through the Undergraduate Curriculum Council (UCC), advising and registrar personnel will review the program in consultation with the department to reformat it to meet these requirements.
- Advising and registrar personnel will also review programs that are not being changed through the UCC, and consult with the department to reformat it to meet these requirements.
- Any substantial changes to programs that result from this process will need to be reviewed and approved by the UCC, who will adopt methods to streamline these changes as much as possible.
- Our goal is to have all programs in the Undergraduate Catalog reviewed and updated for the 2018-19 catalog.

Karen Scott explained Idaho’s Division of Professional Technical Education (PTE) changed their name to Career & Technical Education (CTE), the last hold-out in making this change worldwide. Most of College of Technology programs are sponsored by the CTE Division. Idaho teachers get certification courses through ISU and University of Idaho, so those teachers will be looking for courses with the CTE prefix. To remain competitive, ISU’s course offerings will need to have the updated prefix. She understands this change will be a headache for the Registrar’s Office, DegreeWorks, and transcript tracking. Houghton reminded everyone that changing subject codes (i.e., course prefixes) was part of a larger conversation and becomes problematic from a catalog history perspective: which old courses correlate to which new ones? Scott said the 10 or so remaining students who have credit under the old HRTD courses should be graduating this coming spring, so hopefully this will not be an issue in the future. Scott mentioned there is another proposal in the works where the prefix changes from Child & Family Studies (CFS) to Family & Consumer Sciences (FCS).

Scott described the process by which the degree MAPs were developed; the MAPs will not be used much since most CoEd students are non-traditional students who already have some of the experience and don’t need to follow the same path that non-experienced students need to take. Impact responses are not necessary in this particular case.

Council voted to untable and **approve** [Proposal #13](#) at this time, though it remains listed below in its original place on the agenda.

practices in assessment. Also were asked for each Objective to suggest a list of common courses around the state, and common course numbering for those courses. That would be easier to do in some disciplines than in others. For Tokle's Objective 4 group there were very few common courses offered at all or most of the institutions.

Totlke also reported this week's Mid-Cycle Accreditation Review site visit meetings went well. Houghton said GERC was heavily involved in the mid-cycle review.

BAS elected a new chair of the committee and approved six BAS programs, tabled a few others, and discussed the proposed Honors BAS program, informing the BAS Committee of UCC's decision regarding the identification of eligible faculty for voting on Honors proposals. BAS Committee is undergoing a program review, will select and invite outside members to serve on the BAS program review committee.

8. Information from the Chair:

Houghton met with Debbie Ronneberg regarding the tabled [Proposal #5](#) for the BAS in Robotics. Houghton and Ronneburg will meet with Selena Grace and Joanne Tokle to figure out the BAS program in the context of CTE courses.

On another note, [Proposal #9](#) from ACAD raised concerns about the creation of courses that grant many academic credits unrelated to a specific discipline, and creating new courses that are similar to existing courses. The SBOE is starting to question the proliferation of course offerings at Idaho's higher ed institutions. Discussion. Suggest inviting the Proposal Originator, Kelly Moor, to come to UCC to discuss the proposal.

Houghton and Read walked members through various errors encountered during processing a submitted proposal as examples of things to watch for and correct before signing off on a proposal and submitting to UCC. One thing to keep in mind is that course changes (proposal Part B) are entered into Banner by one catalog editor, and the curriculum changes (proposal Part C) are entered into CourseLeaf by another catalog editor. CourseLeaf uses Banner's course information so all changes to courses must be made in Part B, otherwise they won't appear in the catalog. The greyed-out section in Part C is the historical catalog text and should not be touched. In Part B, use one table per course, copying and pasting tables and course information as needed. This will eliminate errors as the catalog editors scurry to meet the publishing deadline.

Once again, POs were panicking as the submission due date approached. Submission by the September 20 due date simply guarantees that UCC will consider the proposal before the mid-November catalog cut-off date. Later submissions will be accepted and considered as time allows, but are not guaranteed. UCC accepts proposals from January to October, so there shouldn't be a last-minute rush for most proposals. “Deadline” may not be the best word to use. **Council decided to eliminate the words “late” and “deadline”.** Belliston and Hofle volunteered to work on alternate verbiage for the website and proposal form.
